In case of requirements (e.g. by a journal) to retain study data after publication, the BfS confirms that all baseline data are stored at the BfS and can be made available again on request. The recipient will provide written confirmation to BfS that the data have been deleted.
- send an annual report on the progress of the project to the Advisory Committee and the BfS
- include BfS in a suitable way (1-2 co-authors) in all publications relating to the results arising from the research. The BfS is free to abstain from this agreement. In any case, the BfS should be acknowledged and has the right to make comments on publications of research results in scientific journals, meetings and congresses, etc.
- inform the BfS about intended publications (oral or poster presentations) resulting from this study by sending the manuscript (abstract) before submission to a journal (congress) to the BfS.

The recipient shall ensure that its employees comply with the obligations imposed upon the recipient by this agreement as if personally bound by such obligations.
